ASSIGNMENT OF PATENT

This Assignment of Patent ("Agreement") is made by and between BRUCE EGNATER, an individual ("Assignor") and ETI SOUND SYSTEMS, INC., a California corporation, doing business as Boutique Amps Distribution ("Assignee"). 
