ASSIGNMENT

NOW, THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration paid by YKK, the receipt and sufficiency of which are hereby acknowledged, YCA agrees to sell, assign, transfer and convey and by these presents does hereby sell, assign, transfer and convey unto YKK, undivided right, title and interest in and to said patent application, in and to the invention therein set forth and in and to any reissue, renewal, divisional, or continuation thereof, together with all claims for damages by reason of infringement of any patent that is granted or issued upon or claims priority to said patent application and the right to sue for and collect such damages for its own use, the same to be held and enjoyed by YKK for its own use and enjoyment and the use and enjoyment of its successors, assigns or other legal representatives to the full ends of the terms for which the patents are


granted or reissued as fully and entirely as the same would have been held and enjoyed by YCA if this assignment and sale had not been made.

For the same consideration, YCA by these presents does sell, assign and transfer to YKK the full, exclusive and entire right, title and interest in and to any non-U.S. application or applications corresponding to said patent application, in whole or in part, in countries other than the United States, in and to any patents and similar protective rights granted on said non-U.S. applications, and in and to the right to claim any applicable priority rights arising from or required for said non-U.S. applications under the terms of any applicable conventions, treaties, statutes or regulations; said non-U.S. applications to be filed and issued in the name of YKK or its designee insofar as permitted by applicable law; and

For the same consideration, YCA, its successors and its assigns further agree with YKK hereafter to execute, without further consideration, all applications, amended specifications, deeds or other instruments, and to do all acts necessary or proper, to secure the grant of patents and to record or perfect the right conveyed herein in all countries throughout the world.


