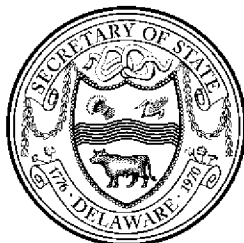



1. The undersigned is the duly elected and acting President of Aptwater, Inc., a Delaware corporation.


