Assignor also hereby authorizes the respective patent office or governmental agency in each jurisdiction to issue any and all patents or certificates of invention that may be granted upon any of the Patents in the name of Assignee, as the assignee to the entire interest therein.


This Assignment shall be binding upon and shall inure to the benefit of the parties and their respective successors and assigns.



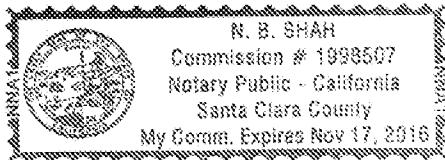
