ASSIGNMENT

In exchange for \$10.00 and other good and valuable consideration, the receipt and sufficiency of which is acknowledged, the below named inventor, (hereinafter referred to as Assignor), hereby assigns to FairwayIQ, ~~INC~~, a corporation of Delaware, having a place of business at 51 Melcher St, Boston, MA 02210, United States of America, and its successors and assigns (collectively hereinafter called "the Assignee"), the entire right, title, and interest throughout the world in the inventions and improvements which are described in or the subject of an application for United States Patent signed by Assignor titled:

which is identified by Attorney Docket No. FIQ-001, for which Assignor filed an application of United States Letters Patent on **March 17, 2014**, assigned Application Serial No. **14/217,319** (hereinafter the "Application").

Assignor covenants that he has the full right to convey the interests assigned by this Assignment, and that he has not executed and will not execute any agreement in conflict with this Assignment. Assignor further agrees that he will, without further consideration: (i) promptly disclose to Assignee's patent attorney any prior art known to Assignor during the pendency of the Application or other US or foreign related applications; (ii) testify in any legal or administrative proceeding and participate in any examiner interview relating to the inventions or improvements described in or subject of the Application; and (iii) provide reasonable assistance to the Assignee to obtain and enforce proper patent protection for the inventions and improvements described in or subject of the Application.

This assignment and all disputes under this assignment shall be governed by the laws of the Commonwealth of Massachusetts. Any and all claims, lawsuits, or disputes of any kind between Assignor and Assignee shall be resolved in federal or state courts in the Commonwealth of Massachusetts.
