ASSIGNMENT

WHEREAS, Anthony Convery, residing at 12 Springhill Road, Moneymore, County Londonderry, BT45 7NG, United Kingdom (hereinafter referred to as Assignor), has invented certain new, original, and ornamental design for a MATERIAL HANDLING APPARATUS, for which a European Community Design Application No. 002590968-0001 was filed in the European Office for Harmonization in the Internal Market (OHIM) on December 4, 2014, and for which a design patent application was executed on even date herewith.

Assignor hereby authorizes and requests the Patent Office Officials in the United States and in any and all foreign countries to issue any and all of said Letters Patent, when granted, to said Assignee as the owner of the entire right, title and interest in and to the same, for the sole use and behoof of said Assignee, its successors and assigns.

FURTHER, Assignor agrees to communicate to said Assignee or its representatives any facts known to Assignor respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all utility, divisional, continuation, continuation-in-part, substitution, renewal, and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said Assignee, make all rightful oaths and generally do everything possible to aid said Assignee, its successors and assigns, to obtain and enforce proper protection for said invention in the United States and in any and all foreign countries.
