TRANSFER AND ASSIGNMENT OF PATENTS

THIS AGREEMENT is made as of May 11, 2015

B. The Assignee has exercised its option to acquire the Patents as of the date hereof;

C. The Assignor is seized of the patents described in the **Schedule "A"** annexed hereto (the "Patents"), and agrees to the absolute assignment to the Assignee of all its right, title and interest in and to the Patents, and all the benefits and advantages to be derived therefrom.

NOW THEREFORE THIS AGREEMENT WITNESSETH that in consideration for certain good and valuable consideration, the receipt and adequacy of which is hereby acknowledged by the Assignor:

1. The Assignor hereby assigns transfers and sets over unto the Assignee, and its successors and assigns, all of the right title and interest, in and to the Patents, together with all of the benefits and advantages to be derived therefrom.

2. The Assignor finally further undertakes that any prior use of the Patents made by it or any of its predecessors in title will benefit wholly and exclusively to the Assignee.

2. The parties hereto agree to execute all such documents and do all such acts, at the cost of the Assignee, as may be necessary to give effect to this assignment of the Patents and the
