compensation, but at the expense of **Stella Alliance, LLC**, its successors, assigns or other legal representatives; and

Assignors hereby appoints the Secretary or any other officer of **Stella Alliance, LLC**, as **Assignors'** attorney-in-fact and agent to execute all documents required or appropriate to perfect or enforce all rights assigned under this Agreement and further authorizes **Assignors'** attorney and attorneys and the attorney and attorneys for **Stella Alliance, LLC** to register this assignment in any and all countries.
