**RELEASE OF SECURITY INTEREST IN PATENTS**

**W I T N E S S E T H**

**WHEREAS**, the Grantor, AIP/Heil Trailer Holdings, Inc., a Delaware corporation, and the holders of the Notes (as defined in the hereinafter described Note Agreement) have entered into to that certain Second Amended and Restated Senior Note Agreement dated as of May 2, 2014 (as heretofore amended, restated, supplemented or otherwise modified, the “Note Agreement”; *capitalized terms used and not defined herein shall have the meanings ascribed to such terms in the Note Agreement*);

**WHEREAS**, the Grantor executed that certain Grant of Security Interest in Patents dated as of December 30, 2011 (as heretofore amended, restated, supplemented or otherwise modified, the “Patent Security Agreement”), which was duly recorded on January 3, 2012, at Reel 027468/ Frame 0738 with the United States Patent and Trademark Office, and granted to the Agent a continuing security interest in and a continuing lien upon, all of Grantor’s right, title and interest in and to all patents and patent applications owned by Grantor, including, without limitation, as set forth on Schedule A attached hereto (collectively, the “Patents”); and


**WHEREAS**, the Agent wishes to release and restore all right, title and interest in and to the Patents to the Grantor and to dissolve those liens and encumbrances with respect to the Patents created by the Patent Security Agreement and any other Senior Note Document.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent, on behalf of itself and the holders of the Notes, does hereby fully and finally release and relinquish all security interests and liens in the Patents granted to the Agent by Grantor.
