

Grantor does hereby convey, release and quitclaim any and all rights title or interest in and to the above described property that the Grantor may have nunc pro tunc effective January 21, 2001 to the Grantee, and to the Grantees' successors and assigns forever, so that neither Grantor nor Grantor's successors, assigns or legal representatives shall have, claim or demand any right title or interest in or to the property or any part thereof.

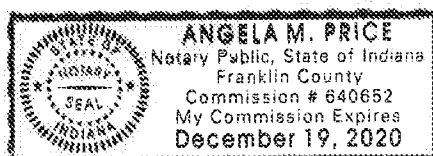
