## ASSIGNMENT

NOW THEREFORE, for good and valuable consideration, the receipt, sufficiency and adequacy of which are hereby acknowledged:

### **1. ASSIGNMENT**

ASSIGNORS hereby sell, assign, and transfer to ASSIGNEE, its successors, and assigns, the entire right, title, and interest throughout the world in and to the Invention, including any and all patent applications and patents of every country for said Invention, also including all provisional, non-provisional, divisional, continuing, substitute, renewal, reissue, and all other applications for patent which have been or shall be filed in the United States and all foreign countries on any of such inventions and/or improvements to said Invention; all original and reissued patents which have been or shall be issued in the United States and all foreign countries on said inventions and/or improvements; and specifically including the right to file foreign applications under the provisions of any convention or treaty and claim priority based on such application in the United States.

### **2. REPRESENTATIONS AND WARRANTIES**

- A. ASSIGNORS hereby represent and warrant that no assignment, grant, mortgage, license, or other agreement affecting the rights and property herein conveyed has been or will be made to others by the undersigned, and that the full right to convey the same as herein expressed is possessed by the undersigned; and
- B. ASSIGNORS hereby represent and warrant, when requested, and at the expense of the ASSIGNEE, to carry out in good faith the intent and purpose of this assignment, the undersigned will execute all papers useful in connection with said United States and foreign applications, including provisional, non-provisional, divisional, continuing, substitute, renewal, reissue, and all other patent applications on any and all said invention and/or

improvements; execute all rightful oaths, declarations, assignments, powers of attorney, and other useful papers; communicate to the ASSIGNEE all facts known to the undersigned relating to said invention and/or improvements and the history thereof; and generally do everything possible which the ASSIGNEE, its successors, assigns, and nominees, shall consider desirable for vesting title to said invention and/or improvements, and for securing, maintaining and enforcing proper patent protection for said invention and/or improvements.

### 3. AUTHORIZATION

ASSIGNORS hereby authorize and request the Commissioner for Patents, or other issuing authority, to issue any and all United States and foreign patents granted for said invention and/or improvements to the above-named ASSIGNEE, its successors, and assigns.

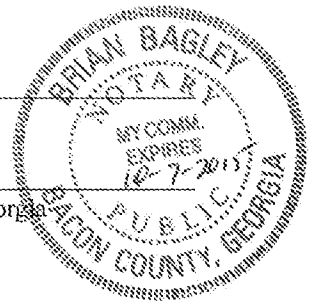
