and all applications, petitions, oaths, declaration and assignments or other papers and instruments which may be necessary in order to carry into full force and effect the sale, assignment, transfer, and conveyance hereby made or intended to be made, and generally do everything possible to aid Assignee, its legal representatives, and assigns to obtain and enforce proper protection for said invention in all countries throughout the world.
