The Commissioner of Patents & Trademarks is hereby authorized and requested to issue any Letters Patent for the Application, and all related

applications thereon, to the Assignee, for its sole use and benefit; and for the use and benefit of its successors and assigns, to the full end of the term for which Letters Patent may be granted, as fully and entirely as the same would have been held by the Assignors had this Assignment and sale not been made.




