CONFIRMATORY DEED OF ASSIGNMENT

THIS CONFIRMATORY DEED OF ASSIGNMENT is made as of the 7th day of January 2015 by and between:

1. **Rolf Tamm**, of Am Fohrnbühl 8, 88682 Salem 2, Germany (the "Assignor"); and
2. **Illinois Tool Works Inc.**, a company incorporated under the laws of the state of Delaware, USA, having an address at 155 Harlem Avenue, Glenview, Illinois 60025, USA (the "Assignee")

WHEREAS

The Assignee agrees to take all steps, execute all documents and do everything reasonably and necessarily required to be done to:



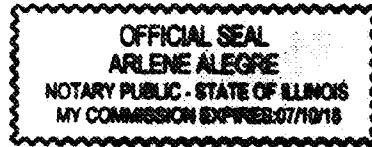
