direct and indirect divisions, continuations and continuations-in-part of said application, and any and all Letters Patent in the United States which may be granted therefor and thereon, and reissues, reexaminations and extensions of said Letters Patent, and all rights under all available International Agreements, Treaties and Conventions for the protection of intellectual property in its various forms in every participating country, and all applications for patents (including related rights such as utility-model registrations, inventor's certificates, and the like) heretofore or hereafter filed for said inventions and improvements in any foreign country including, but not limited to, all divisions, continuations, continuations-in-part thereof, and further including, but not limited to, extensions, renewals, substitutes and reissues granted for said inventions and improvements in any foreign country, the same to be held and enjoyed by Assignee, for its own use and benefit and the use and benefit of its successors, legal representatives and assigns, to the full end of the term or terms for which such Letters Patent may be granted and/or extended, as fully and entirely as the same would have been held and enjoyed by Assignor, had this sale and assignment not been made;

AND for the same consideration, Assignor hereby sells, assigns, transfers and sets over to Assignee, any and all claims and demands that Assignor may have against any person or entity relating to the right, title and interest in and to said inventions and improvements thereon, and said application for Letters Patent of the United States, and any Letters Patent of the United States, and of foreign jurisdictions, or other rights to be obtained therefor and thereon, including but not limited to, any claim of infringement of rights, including provisional rights, whether heretofore or hereafter accrued, together with the right to retain for Assignee any and all sums that Assignee may obtain or recover as a result of the assertion or enforcement of any such claim or demand;

AND for the same consideration, Assignor hereby represents and warrants to Assignee, its successors, legal representatives and assigns, that, at the time of execution and delivery of these presents, except for any rights, titles and/or interests that have arisen to Assignee under law or that have already been transferred to Assignee, Assignor is the sole and lawful owner of the entire right, title and interest in and to: the said inventions and improvements thereon, and said application for Letters Patent above-mentioned, and any Letters Patent of the United States and of any foreign jurisdiction to be obtained therefor and thereon, and that the same are unencumbered, and that Assignor has good and full right and lawful authority to sell and convey the same in the manner herein set forth;

AND for the same consideration, Assignor hereby covenants and agrees to and with Assignee, its successors, legal representatives and assigns, that Assignor will sign all papers and documents, take all lawful oaths and do all acts necessary or required to be done for the procurement, maintenance, enforcement and defense of any Letters Patent and applications for Letters Patent for said inventions, without charge to Assignee, its successors, legal representatives and assigns, whenever counsel of Assignee, or counsel of its successors, legal representatives and assigns, shall advise: that any proceeding in connection with said inventions, or said application for Letters Patent, or any proceeding in connection with any Letters Patent or applications for Letters Patent for said inventions including but not limited to interference proceedings, is lawful and desirable; or, that any division, continuation or continuation-in-part of any application for Letters Patent, or any reissue, reexamination or extension of any Letters Patent, to be obtained thereon, is lawful and desirable;

AND for the same consideration, Assignor hereby authorizes and requests the United States Commissioner for Patents, and any officials of foreign countries whose

duty it is to issue patents on applications as aforesaid, to issue all patents for said improvements to Assignee, for the sole use and benefit of Assignee, its successors, legal representatives and assigns;

AND Assignor acknowledges an obligation of assignment of this invention to Assignee at the time the invention was made.


