

AND FURTHER, APW hereby authorizes and requests the United States Commissioner of Patents and Trademarks and all other issuing authorities to issue all Patents on said invention or resulting therefrom to the Company as assignee of the entire interest, and covenants that APW has the full right to do so, and agrees that APW will communicate to the Company or its representatives any facts known to it respecting said inventions and testify in any legal proceeding, execute all divisional, continuing and reissue applications and all assignments of said inventions and of the right to apply for Letters Patents therefrom in all countries, make all rightful oaths, sign all other lawful papers and generally do everything reasonably possible to aid the Company, its successors, assigns and nominees, to obtain and enforce proper patent protection for said invention in all countries in the world all at the sole expense of the Company.

**AND FURTHER**, APW authorizes any officer of the Company to execute on behalf of APW all documents necessary for the filing of any such applications including divisional, continuing and reissue applications and all assignments of said inventions and all documents necessary to apply for Letters Patents therefore in all countries including making all rightful oaths, signing all other lawful papers, and generally doing everything reasonable and necessary on behalf of APW to obtain and enforce proper patent protection for the Company for said inventions in all counties in the world.
