Patent Assignment

THIS PATENT ASSIGNMENT (this “*Assignment*”), dated as of January 1, 2011 (the “*Effective Date*”), is made by and between:

Dart Neuroscience LLC, a Delaware limited liability company (“*Assignor*”), and

The Assignor does hereby:

SELL, ASSIGN AND TRANSFER to Assignee, the entire right, title and interest in the patents and patent applications listed on **Exhibit A**, attached hereto, and any additions, provisionals, continuations, continuations-in-part, divisionals, continued prosecution applications, reissues, and re-examination patents or applications thereof or any other applications or patents claiming benefit of the filing date of any such application or patent listed on Exhibit A (the “*Assigned Interests*”);

AUTHORIZE AND REQUEST the issuing authority to issue any and all United States and foreign patents granted on any of the Assigned Interests to Assignee;

WARRANT AND COVENANT that no assignment, grant, mortgage, license or other agreement affecting the rights and property herein conveyed has been or will be made to others by Assignor, and that the full right to convey the same as herein expressed is possessed by Assignor; and

COVENANT that, when requested by Assignee and at the sole expense of Assignee, to carry out in good faith the intent and purpose of this Assignment, Assignor will (a) execute all divisional, continuing, continuation-in-part, substitute, renewal, reissue, and all other patent applications on any and all of the Assigned Interests, (b) execute all rightful oaths, declarations, assignments, powers of attorney and other papers related to the Assigned Interests, (c) communicate to Assignee all facts known to Assignor relating to the Assigned Interests and the history thereof, and (d) generally do everything possible which the Assignee will consider desirable for securing, maintaining and enforcing proper patent protection for such Assigned Interests and for vesting title to the Assigned Interests in the Assignee;
