ASSIGNMENT

We confirm that, at the time the invention was made, we were under an obligation to assign the invention to Buerkert Werke GmbH.

We hereby grant the law firm of Klarquist Sparkman, LLP, the power to insert on this Assignment, the U.S. Application Number once the application is filed, as well as any further information that may be necessary or desirable in order to comply with all applicable legal requirements, including the rules of the United States Patent and Trademark Office, for submitting and recording this document.
