ASSIGNMENT OF INVENTION

This Assignment of Invention, which shall be fully effective and legally binding as of June 20, 2014, is made by and between JOSEPH DONNAN, an individual, hereinafter referred to as "ASSIGNOR", DANIEL MESSER, an individual residing at 5622 Blossom, Cote St. Luc, Montreal Canada ("JOINT INVENTOR") and RAILHEAD CORPORATION, a corporation organized in the state of Illinois and having a principal place of business located at 12549 S. Laramie Ave., Alsip, Illinois 60803, hereinafter collectively referred to as "ASSIGNEE". All of ASSIGNOR, JOINT INVENTOR, and ASSIGNEE may be referred to individually herein and throughout as a "Party".

In consideration of the payment by ASSIGNEE to ASSIGNOR of the sum of One Dollar (\$1.00), the receipt and sufficiency of which is hereby acknowledged, and for the other good and valuable consideration, ASSIGNOR hereby sells, assigns, and transfers to ASSIGNEE and the successors, assigns and legal representatives of ASSIGNEE, any and all interest that ASSIGNOR has for the United States and its territorial possessions and in all foreign countries, including all rights to claim priority in and to any and all improvements which are disclosed in an invention entitled "Locomotive Headlamp", the disclosure of which shall be filed by ASSIGNEE and JOINT INVENTOR, with the U.S. Patent & Trademark Office on or about June 20, 2014 as a provisional patent application (the "Invention");

ASSIGNOR and JOINT INVENTOR hereby covenant that they are joint and exclusive inventors of the Invention, and that they have the legal authority to enter into this agreement;

ASSIGNOR and JOINT INVENTOR hereby covenant that no assignment, sale, agreement, or encumbrance has been or will be made or entered into which would conflict with this assignment;

JOINT INVENTOR and ASSIGNEE hereby covenant that they will not assign and/or license their respective interests in the invention to a third party without first obtaining the other Party's written permission;

Any and all licenses and/or assignments made by JOINT INVENTOR and/or ASSIGNEE to any third party without having received the other Party's written permission shall make such assignment and/or license null and void. Alternatively and/or additionally, in the event that such assignment and/or license cannot be made legally null and void, the Party having made such assignment and/or license, shall pay to the other Party all monies, interests, profits, and any other earnings, resulting from the assignment and/or license and owed to such Party by the third party to which the assignment and/or license was made.

ASSIGNOR and JOINT INVENTOR further covenant that ASSIGNEE will promptly, upon its request, be provided with all pertinent facts and documents relating to said invention and legal equivalents as may be known and accessible to ASSIGNOR and JOINT INVENTOR and will testify as to the same in any interference, litigation or proceeding related thereto and will promptly execute and deliver to ASSIGNEE for its legal representatives any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce said application, said invention and said Letters Patent and said equivalents thereof which may be necessary or desirable to carry out the purposes thereof.


