RELEASE OF SECURITY INTEREST

This RELEASE OF SECURITY INTEREST ("Release") is made as of June 16, 2015 by and among Philip S. Sassower and Susan O. Sassower (each individually, a "Secured Party" and, collectively the "Secured Parties") and Xplore Technologies Corporation of America, a Delaware corporation having a business address at 14000 Summit Drive, Ste. 900, Austin, TX 78728 ("Grantor").

W I T N E S S E T H

WHEREAS, the Secured Parties and the Grantor were parties to that certain Letter of Credit Reimbursement, Compensation and Security Agreement dated as of May 29, 2009, as amended (the "Security Agreement"), wherein Grantor granted the Secured Parties a security interest in and to, among other things, the Intellectual Property (as defined in the Security Agreement), including but not limited to the U.S. patents and trademarks identified on Schedule A attached hereto (such patents and trademarks (and the applications in connection therewith), together with all goodwill of the business associated therewith and symbolized thereby, and the right to sue for past, present and future infringements and dilutions, and all rights corresponding thereto, and all income, fees, royalties, proceeds and other payments at any time due or payable with respect thereto, the "Intellectual Property");

WHEREAS, the Security Agreement was recorded with the U.S. Patent and Trademark Office (the "USPTO") on June 8, 2009;

WHEREAS, the Grantor has satisfied the terms of the Security Agreement and requests a specific release of the security interest granted and recorded against the Intellectual Property with the USPTO; and

WHEREAS, the Secured Parties desire to grant to the Grantor a specific release of the security interest granted and recorded against the Intellectual Property with the USPTO.

NOW THEREFORE, for good and valuable consideration previously tendered by the Grantor, the receipt and sufficiency of which are hereby acknowledged, each Secured Party does hereby relinquish and release the entirety of the security interest in the Intellectual Property and reassigns forever to Grantor all right, title and interest of any nature whatsoever which such Secured Party holds in or to the Intellectual Property and associated common law rights and goodwill appurtenant thereto, and further agrees that it shall execute all other documents and do all other acts necessary to relinquish and effect the release of such rights to Grantor.


