ASSIGNMENT OF PATENTS

SJS Paintball, LP, a Texas limited partnership of Richardson, Texas ("Assignor") is the owner of certain United States Letters Patent and improvements disclosed therein, described on Exhibit A to this Assignment, which Exhibit A is incorporated by reference, ("the Patents").

And for the same consideration, Assignor sells transfers and assigns to assignee all damages for past infringements of the Patents.

Assignor covenants that it has the full right to convey the entire interest assigned, and that it has not executed, and will not execute, any agreement in conflict with this assignment.


Assignor further covenants and agrees that it will communicate to Assignee any facts known to it respecting the Patents and testify in any legal proceeding, sign all lawful papers, execute all reissue applications, make all rightful oaths and generally do everything possible to aid Assignee to obtain and enforce proper patent protection for the improvements in all countries.

This assignment is effective June 22, 2015.

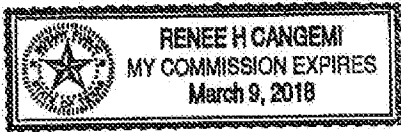
