and all reissues, extensions, renewals, divisions and continuations thereof, to the full end of the term or terms for which said Letters Patent may be issued, to be held and enjoyed by the said Assignee, its successors and assigns the same as it would have been held and enjoyed by **Yuan-Chang JAO**, if this assignment and sale had not been made.

AND, **Yuan-Chang JAO**, hereby authorizes and requests the Commissioner of Patents and Trademarks to issue all such Letters Patents to the said Assignee, in accordance with this instrument of assignment.

Yuan-Chang JAO, hereby represents and warrants that there are no rights or interests outstanding inconsistent with the rights and interests granted herein and that **Yuan-Chang JAO**, will not execute any instrument or grant or transfer any rights or interests inconsistent therewith, and **Yuan-Chang JAO**, binds himself and his heirs, executors, administrators, employees and legal representatives, as the case may be, to execute and deliver to the said Assignee, its successors and assigns, any further documents or instruments and do any and all further acts that may be deemed necessary by the said Assignee, his successors and assigns, to file applications for the said improvements and invention in any country where he may elect to file such applications, and that may be necessary to vest in the said Assignee, his successors and assigns, the title herein conveyed, or intended so to be, and to enable such title to be recorded in the United States and foreign countries where such application or applications may be filed.

AND, **Yuan-Chang JAO**, further covenants and agrees, in consideration of the premises, that he, his executors and administrators will, at any time upon request, communicate to the said Assignee, his successors and assigns, any facts relating to the said invention and improvements and the history thereof, known to him or his successors and assigns, and that he will testify as to the

same in any interference or other proceeding when requested to do so by the said Assignee, his successors and assigns.

The undersigned hereby grants Muncy, Geissler, Olds & Lowe, P.C. the power to insert on this Assignment any further identification which may be necessary or desirable in order to comply with the rules of the U.S. Patent and Trademark Office for recordation of this document.
