entirely as the same would have been held and enjoyed by Assignors, had this sale and assignment not been made.

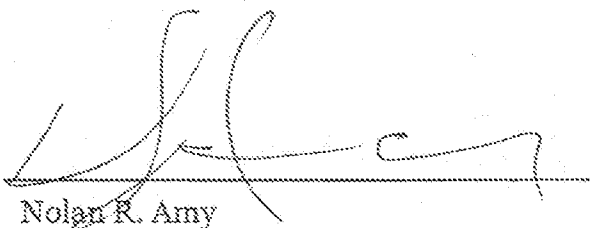

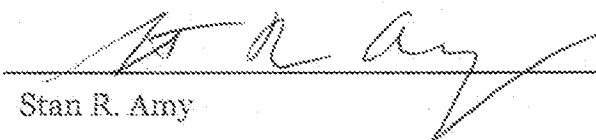
