

NOW THIS INDENTURE WITNESSETH, that for the sum of one dollar and other valuable consideration to us in hand paid, the receipt of which is hereby acknowledged, I hereby assign, sell, and transfer unto said Sphinx Electronics GmbH & Co KG, the entire right, title, and interest in said invention, said application, and in and to any Design or Letters Patent of the United States, and countries foreign thereto, which may be granted for said invention, and in and to any and all priority rights, rights under the International Convention for the Protection of Industrial Property, rights under the Patent Cooperation Treaty, and other benefits accruing or to accrue to me with respect to the filing of applications for patents or securing of patents in the United States and countries foreign thereto. This assignment assigns the right to claim priority to any previously filed provisional or utility application noted herein, as well as the right to be granted a patent in PCT Contracting States.

And I hereby authorize and request the Commissioner of Patents and Trademarks to issue said United States Design or Letters Patent to said Sphinx Electronics GmbH & Co KG, as the assignee of the whole right, title, and interest thereto.


