Notice of Release of
Security Interest in Patents

Grantor/Inventor: YILING XIE ("XIE"), on the one hand, and;

Secured Party/Releasor: Marcolin U.S.A. Eyewear Corp., a New Jersey corporation (successor by merger to VIVA IP CORP.) ("VIVA");

Collectively XIE and VIVA are referred to as the Parties.

Whereas XIE and Viva IP Corp. entered into a certain Patent License Agreement ("Agreement") executed on July 9, 2003, and in accordance with the terms of the Agreement, further executed a grant of security interest in favor of Viva IP Corp., resulting in certain security interest recorded to US PTO for the following patents/applications portfolio ("Portfolio"):

Whereas, XIE and VIVA entered into subsequent amendments ("Amendments") to the Agreement, amending certain terms, including the last amendment terminating the Agreement as of January 14, 2015;

Whereas, as of December 31, 2014, Viva IP Corp. was merged with and into Viva Optique, Inc., a New Jersey corporation, and Viva Optique, Inc. survived the merger, thus by operation of law becoming vested with all rights and obligations formerly held by Viva IP Corp.;

Whereas, immediately upon consummation of the merger, Viva Optique, Inc. changed its name to Marcolin U.S.A. Eyewear Corp.

Whereas, XIE and VIVA hereby acknowledge and agree that the security interests previously granted and recorded in the foregoing Portfolio are now released, in accordance with the termination of Agreement and amendments executed between them; XIE and VIVA further acknowledge that, as between them, XIE is now the sole owner of all interest pertaining to the foregoing Portfolio.

Accordingly, with sufficient and valid consideration between them, Parties agree to execute and record this instrument to release the prior grant of the security interest pertaining to the Portfolio, so that XIE would own the full rights, as between XIE and VIVA, to the Portfolio free and clear of any lien or encumbrance.


