RELEASE OF SECURITY INTEREST IN PATENT RIGHTS

This **RELEASE OF SECURITY INTEREST IN PATENT RIGHTS**, dated as of June 26, 2015 (this "Release"), is made by **BANK OF AMERICA, N.A.** (the "Assignor"), in its capacity as administrative agent under that certain Credit Agreement, dated as of November 27, 2012 (as amended, restated, amended and restated, extended, supplemented or otherwise modified from time to time, the "Credit Agreement"), in favor of FTI Consulting, Inc. and FTI Consulting Technology LLC (each, an "Assignee" and collectively, the "Assignees"). Capitalized terms used but not defined herein shall have the meanings set forth in the Credit Agreement.

W I T N E S S E T H:

WHEREAS, the Assignor and the Assignees are parties to (i) that certain Security Agreement, dated as of November 27, 2012 (the "Security Agreement") and (ii) that certain Notice of Grant of Security Interest in Patents, dated as of November 27, 2012 (the "Patent Security Agreement");

WHEREAS, pursuant to the Patent Security Agreement, each Assignee granted to the Assignor a security interest in all of such Assignee's right, title and interest in and to the items set forth on Schedule 1 hereto (the "Patents"), together with all proceeds of such Patents and all causes of action arising prior to or after the date hereof for infringement of such Patents or unfair competition regarding the same (collectively, the "Patent Collateral");

WHEREAS, the Patent Security Agreement was recorded with the United States Patent and Trademark Office ("USPTO") on December 10, 2012 at Reel/Frame 029434/0087;

WHEREAS, the Assignor as of the date hereof no longer has any right, title or interest in, to and under the Patent Collateral; and

WHEREAS, the Assignees desire that the Assignor terminate and release its security interest in the Patent Collateral.

NOW THEREFORE, in consideration of the premises, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor hereby terminates, releases and discharges fully, without representation, warranty or recourse of any kind, its security interest in the Patent Collateral, and reassigns and transfers to the Assignees all right, title and interest that the Assignor may have in, to and under the Patent Collateral.

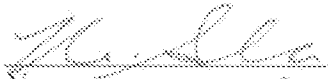
