**ASSIGNMENT OF INVENTION**

WHEREAS, I, **WU, Huaqiang**, Qinghuayuan, Haidian District, Beijing 100084, P. R. China; **YUAN, Shuoguo**, Qinghuayuan, Haidian District, Beijing 100084, P. R. China; **LI, Han**, Qinghuayuan, Haidian District, Beijing 100084, P. R. China; and **QIAN, He**, Qinghuayuan, Haidian District, Beijing 100084, P. R. China, have invented certain new and useful improvements in a **METHOD FOR PREPARING A MOLYBDENUM DISULFIDE FILM USED IN A FIELD EMISSION DEVICE**, for which an application for Letters Patent in the United States was filed on June 16, 2015 and assigned U.S. Appl. No. 14/740,359, claiming priority to Chinese patent application no. 201410176131.5 filed April 29, 2014;

And I hereby authorize and request the Commissioner of Patents and Trademarks to issue said United States Letters Patent to said **TSINGHUA UNIVERSITY** as the assignee of the whole right, title, and interest thereto.

And I further agree to sign and properly execute such necessary and lawful papers for application for foreign patents, for filing subdivisions of said application for patent, and for obtaining any reissue or reissues of any Letters Patent which may be granted for my aforesaid invention, as the assignee thereof shall hereafter require and prepare at its own expense.
