3. Assignor further sells, assigns and transfers to Assignee all of its right, title and interest in and to all claims for damages, accounting of profit and all other legal remedies by reason of any infringement of the Patents, with the right to sue and collect the same.

4. Assignor will, upon reasonable request, and without further consideration, execute such further documents as are reasonably necessary to vest title to the Patents in Assignee, its successors, assigns and legal representatives or nominees, and to enforce such rights in Assignee, its successors, assigns and legal representatives or nominees.

5. This Patent Assignment and all the terms hereof will inure to the benefit of and be binding upon Assignor and Assignee and their respective successors, assigns and legal representatives.

6. This Patent Assignment is subject to the terms and conditions of the Contribution Agreement and all of the representations, warranties, covenants, agreements, limitations and

restrictions contained therein, all of which will survive the execution and delivery of this Patent Assignment as and to the extent provided in the Contribution Agreement.


