RELEASE OF SECOND LIEN PARENT INTELLECTUAL PROPERTY SECURITY AGREEMENT SUPPLEMENT

This Release of Second Lien Parent Intellectual Property Security Agreement Supplement (this "Release") is made as of June 23, 2015, by Guggenheim Corporate Funding, LLC, a New York limited liability company, in its capacity as Second Lien Collateral Agent under (and as defined in) the Security Agreement referred to below (the "Secured Party") for the benefit of Playpower, Inc., a Delaware corporation; Playpower Holdings Inc., a Delaware corporation; E-Z-Dock, Inc., a Minnesota corporation; Kid Play, Inc., a Delaware corporation; Miracle Recreation Equipment Company, an Iowa corporation; Playpower LT Farmington, Inc., a Missouri corporation; Shade Structures, Inc., a Delaware corporation; and Soft Play, L.L.C., a Delaware limited liability company (the "Debtors"). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement.

WITNESSETH:

WHEREAS, the Debtors and the Secured Party are parties to that certain Second Lien Parent Intellectual Property Security Agreement Supplement dated as of January 30, 2014 (as amended, restated or otherwise modified through the date hereof, the "Security Agreement"), pursuant to which the Debtors have granted to the Secured Party for its benefit and the benefit of various other financial institutions, a security interest in the intellectual property set forth on Schedules A, B and C hereto (the "IP") and the goodwill of the business symbolized by such IP, and the registrations and applications therefor (together with the IP, the "IP Collateral");

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office at Reel 5207/Frame 0619 for trademarks and Reel 032153/Frame 0332 for patents; and

WHEREAS, the Debtors have requested that the Secured Party provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release of its security interest, and claims of security interest, in the IP Collateral and the Secured Party is willing to provide such document, subject to the terms hereof.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby agrees as follows:

- 1. The Secured Party does hereby terminate, release and discharge the entirety of any and all security interests that it may have in, and all claims, whether presently existing or hereafter acquired or created, pursuant to the Security Agreement to the IP Collateral and any right, title or interest of the Secured Party in such IP Collateral shall hereby terminate, cease and become void. The Secured Party hereby assigns, transfers and conveys any and all right, title or interest of the Secured Party in the IP Collateral to the Debtors. Secured Party agrees to provide cooperation and assistance to the Debtors (including, without limitation, the execution and delivery of any and all documents or other instruments, which must be prepared and filed by the Debtors, at the sole cost and expense of the Debtors) reasonably requested by the Debtors to more fully and effectively effect the purposes of this Release.
- 2. This Release may be executed in any number of counterparts (including electronic transmission and facsimile counterparts), each of which when so executed and delivered shall be

deemed an original, but all such counterparts together shall constitute but one and the same instrument.

3. This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York.

IN WITNESS WHEREOF, the undersigned has caused this Release of Second Lien Parent Intellectual Property Security Agreement Supplement to be executed and delivered as of the date first written above.
