WHEREAS, **Amit SINHA** (hereinafter referred to as "ASSIGNOR") has invented certain new and useful improvements in an invention entitled:


**CLOUD BASED MOBILE DEVICE MANAGEMENT SYSTEMS AND METHODS**
