Assignors hereby authorize and request the Patent and Trademark Office officials in the United States of America and any and all foreign countries to issue any and all of said Letters Patent, when granted, to said **Proteus Industries, Inc.**, as the assignee of **Assignors'** entire right, title and interest in and to the same for the sole use and behoof of said **Proteus Industries, Inc.**, its successors and assigns to the full end of the term for which any of said Letters Patent may be granted as fully and entirely as the same would have been held by **Assignors** had this assignment and sale not been made;

Further, **Assignors** agree to communicate to **Proteus Industries, Inc.** or its representatives any facts known to **Assignors** respecting said invention, to testify in any legal proceeding, to sign all lawful papers, to execute all divisional, continuation, substitution, renewal and reissue applications, to execute all necessary assignment papers to cause any and all of said Letters patent to be issued to said **Proteus Industries, Inc.**, to

make all rightful oaths and generally to do everything possible to aid said **Proteus Industries, Inc.**, its successors and assigns to obtain and enforce proper protection for said invention in the United States of America and in any and all foreign countries without further compensation, but at the expense of **Proteus Industries, Inc.**, its successors, assigns or other legal representatives; and

Assignors hereby appoints the Secretary or any other officer of **Proteus Industries, Inc.**, as **Assignors'** attorney-in-fact and agent to execute all documents required or appropriate to perfect or enforce all rights assigned under this Agreement and further authorizes **Assignors'** attorney and attorneys and the attorney and attorneys for **Proteus Industries, Inc.** to register this assignment in any and all countries.

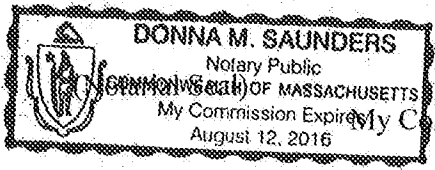
