TRANSFER AND ROYALTY AGREEMENT

THIS TRANSFER AND ROYALTY AGREEMENT ("Agreement") made this 8th day of December, 2010, (the "Effective Date") by and between Arkansas Children's Hospital, an Arkansas non-profit corporation ("ACH") and Bluefish, LLC, an Arkansas limited liability company ("Bluefish"). As used in this Agreement, "Party" means either ACH or Bluefish, as appropriate, and "Parties" means ACH and Bluefish. This Agreement is also entered into by the Bluefish Parties, as identified and for the purposes set forth in Section 10.

WHEREAS, ACH has developed and is the owner of all right, title and interest in and to software programs described in Exhibit A attached hereto (the "Programs").

WHEREAS, Bluefish desires to acquire the Programs from ACH and ACH desires to convey the Programs to Bluefish on the terms and conditions set forth in this Agreement;

NOW, THEREFORE, in consideration of the mutual promises contained herein, it is agreed as follows:

1. Transfer and Assignment.

1.3 Assignment of Patent Application. ACH currently has pending a patent application for the Program "Care Hub", which patent application has been initially rejected by the U.S. Patent and Trademark Office. ACH transfers, conveys and assigns the patent application to Bluefish, and Bluefish assumes, and shall have the sole control over the patent application from and after the Effective Date. Such assignment is "as is, where is" and ACH makes no representation or warranty that such application will or should be granted.

Carehub

In Room patient education-entertainment system including on-demand, age-appropriate movies, internet, chat, education material, journals, web cams, xbox game ordering, music, pictures and "tivo" like control of TV.
