THIS DEED is made the 27th day of September 2013

BETWEEN:-

(1) JULIAN MORRIS, a British citizen, c/o 14 Minns Business Park, West Way, Oxford, Oxfordshire, OX2 0JB, United Kingdom (hereinafter called "the Inventor" which expression where the context so allows shall include his personal representatives and assigns); and

(2) OMG PLC, a company incorporated under the laws of England and Wales, and having its registered office at 14 Minns Business Park, West Way, Oxford, Oxfordshire, OX2 0JB, United Kingdom (hereinafter called "the Company" which expression where the context so allows shall include its successors and assigns).

WHEREAS

(A) The Inventor claims to be the inventor (together with James Srinivasan and Eric Greveson) of an invention relating to "Determination of Position from Images and Associated Camera Positions" ("the Invention") full particulars of which have been communicated by him to the Company and which he is informed is or is intended to be the subject of one or more applications for patent protection initially as identified in the Schedule hereto and in respect of which he has (as he hereby acknowledges) approved a specification as submitted to him by the Company's Patent Attorneys, J A Kemp.

(B) The Invention was made by the Inventor while in the employment of the Company and in the course of his normal duties or in the course of duties falling outside his normal duties but specifically assigned to him and the circumstances were such that an invention might reasonably be expected to result from the carrying out of his duties and furthermore because of the nature of

his duties as a Director and the particular responsibilities arising from the nature of these duties he had a special obligation to further the interests of the Company and accordingly the Invention is to be taken (as between the Inventor and the Company) to belong to the Company for the purposes of the Patents Act 1977 and for all other purposes of whatsoever nature.

(C) The Inventor has agreed at the request of the Company to execute this Deed on the terms herein contained


NOW THIS DEED WITNESSES as follows:

1. In pursuance of the said agreement and in consideration of the premises the Inventor HEREBY ASSIGNS and CONFIRMS unto the Company the Invention and the patent application identified in the Schedule hereto and all patents granted thereon AND the full and exclusive benefit thereof TOGETHER WITH all rights of action and powers accruing or belonging to the Inventor AND the full right to apply for and obtain a patent or patents or other similar forms of protection in respect of the Invention in the United Kingdom of Great Britain and Northern Ireland and the Isle of Man (hereinafter called "the United Kingdom") and in all other countries of the world including the benefit of any priority date and the right to make applications whether under any national law or under the International Convention for the Protection of Industrial Property or under any other applicable convention or treaty TO HOLD the same unto the Company absolutely.

2. The Inventor on behalf of himself his executors administrators and assigns HEREBY COVENANTS and AGREES with the Company as follows:-

(a) that he will at any time hereafter (whether or not he remains in the employ of the Company) and from time to time at the request and expense of the Company promptly execute and sign all such instruments applications and documents and do all such acts and things as may be required by the Company to enable the Company to enjoy the full benefit of the rights hereby confirmed and assigned including applying for and obtaining a patent or patents or other similar forms of
