NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, WAMBAUGH, by these presents does hereby sell, assign, transfer and set over unto RW/SB the full and exclusive right, title and interest to the said invention and all non-provisional patent applications claiming priority of common subject matter of said invention, all continuations, divisions, substitutions, continuations-in-part thereof, and all United States Letters Patents which may be granted thereon and all reissues and extensions thereof, and all priority rights under the International Convention for the Protection of Industrial Property for every member country, and all applications for patents—including related rights such as utility-model registrations, inventor's certificates, and the like— heretofore or hereafter filed for said improvements in any foreign countries and WAMBAUGH hereby authorizes and requests the United States Commissioner of Patents and Trademarks, and any officials of foreign countries whose duty it is to issue patents on applications as aforesaid, to issue all patents for said improvements to RW/SB, the entire right, title, and interest in and to the same, for its sole use and behoof and for the use and behoof of its legal representatives, to the full end of the term for which said Patent may be granted, as fully and entirely as the same would






