NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Bank hereby:


1. Releases, terminates and discharges all security interests and liens in that patent identified in **Schedule A** hereto, without recourse or representation or warranty, express or implied of any kind.
