ASSIGNMENT AND AGREEMENT



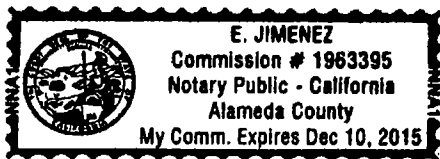
