### 1. ASSIGNMENT

for which United States Design Patent No. Des. 407,016 issued (the "Patent") to Martin A. Nastasia, (now deceased) the inventor and husband of ASSIGNOR. ASSIGNOR has owned a ½ interest in the Patent by virtue of her community property interest in the Patent and inherited Martin A.
