

RELEASE OF PATENT SECURITY INTEREST

RELEASE OF PATENT SECURITY INTEREST, dated July 7, 2015 ("Release") by BARCLAYS BANK PLC, a bank, located at 1301 Avenue of the Americas, New York, New York, 10019, and BANK OF AMERICA, N.A., a national association, with offices located at 333 South Hope Street, Los Angeles, California 90071, in their capacity as collateral agents pursuant to the Credit Agreement (in such capacity, the "Collateral Agents"), in favor of STANDARD AERO (SAN ANTONIO) INC., a Delaware corporation, located at 3523 General Hudnell Drive, San Antonio, Texas 78226 (the "Pledgor"). Unless otherwise defined herein, terms defined in the Security Agreements (as defined below) and used herein have the meaning given to them in the Security Agreements.

WITNESSETH:

WHEREAS, pursuant to the Security Agreements, the Pledgor pledged and granted to the Collateral Agents for the benefit of the Secured Parties, a lien on and security interest in and to all of the right, title and interest of such Pledgor in, to and under the following Pledged Collateral of such Pledgor (collectively, the "Patent Collateral"): (a) Patents issued or assigned to, and all patent applications made by, such Pledgor (whether applied for or issued in the United States or any other country or any political subdivision thereof), including those Patents of such Pledgor listed on Schedule I attached hereto together with any and all (i) rights and privileges arising under applicable law with respect to such Pledgor's use of any patents, (ii) inventions and improvements described and claimed therein, (iii) reissues, divisions, continuations, renewals, extensions and continuations-in-part thereof and amendments thereto, (iv) income, fees, royalties, damages, claims and payments now or hereafter due and/or payable thereunder and with respect thereto including damages and payments for past, present or future infringements thereof, (v) rights corresponding thereto throughout the world and (vi) rights to sue for past, present or future infringements thereof; and (b) to the extent not included in the foregoing, all Proceeds of any and all of the foregoing; provided, however, that the foregoing grant did not apply to any Excluded Property.

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Pledgor and each Collateral Agent hereby agree as follows:

SECTION 1. Release of Security Interest in Patent Collateral. Collateral Agents hereby terminate and release any and all of their lien on and security interest in all of their right, title and interest in, to and under the Patent Collateral including, but not limited to, the patents and patent applications on Schedule 1 attached hereto.

SECTION 2. <u>Recordation</u>. Collateral Agents hereby authorize and request that the Commissioner of Patents and Trademarks of the PTO record this Release.

SECTION 3. <u>Counterparts</u>. This Release may be executed in any number of counterparts, all of which shall constitute one and the same instrument, and any party hereto may execute this Release by signing and delivering one or more counterparts.
