RELEASE OF SECURITY INTEREST IN U.S. PATENT NO. 6,721,178

THIS RELEASE OF SECURITY INTEREST IN U.S. PATENT NO. 6,721,178 (this "Release") is made and effective as of July 28, 2015 and granted by WELLS FARGO BANK, NATIONAL ASSOCIATION, as administrative agent for the lenders (in such capacity, the "Administrative Agent"), under the Grant of Patent Security Agreement referred to below, in favor of OMNICELL, INC., a Delaware corporation ("Grantor").

WHEREAS, the Grantor executed a Grant of Patent Security Interest, dated as of September 25, 2013, in favor of the Administrative Agent (the "Patent Security Agreement"), which was recorded in the United States Patent and Trademark Office on September 27, 2013, at Reel 031302, Frame 0026, pursuant to which Grantor granted to the Administrative Agent, a security interest in and to the Patent Collateral (as defined in the Patent Security Agreement) referred to in Schedule A thereto, and all good will associated with the Patent Collateral; and

WHEREAS, Grantor has notified the Administrative Agent that United States Patent No. 6,721,178, referred to in more detail in Exhibit I hereto (the "'178 Patent"), was erroneously included in Schedule A to the Patent Security Agreement, and now requests that the Administrative Agent release its security interest and lien upon the '178 Patent.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent hereby releases its lien on and security interest in all Grantor's right, title and interest in and to the '178 Patent and reassigns any and all interest it may have in the '178 Patent to Grantor.
