KNOTLESS SUTURE ANCHORING DEVICES AND TOOLS FOR IMPLANTS

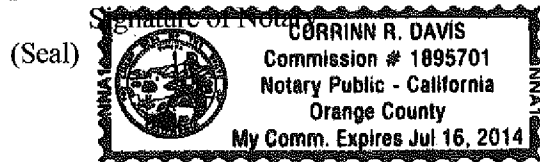

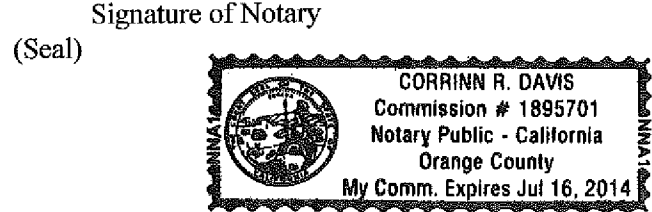
