## INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT ("IP Assignment"), dated effective as of February 2, 2015, is made by ISIMET, LLC, a Texas limited liability company ("ISIMET"); MAPA Products, LLC, a Texas limited liability company ("MAPA"); and Philip A. Parker and Margaret A. Parker, individuals (collectively with ISIMET and MAPA, the "Seller") located at 103 W. CJ Wise Parkway, Naples, TX 75568, in favor of ISIMET / NAPA, LLC, a Colorado limited liability company ("Assignee"), the assignee of certain assets of Seller pursuant to that Asset Purchase Agreement by and among Seller and WCM Industries, Inc., a Colorado corporation ("Buyer"), dated as of February 2, 2015 (the "Asset Purchase Agreement"). Capitalized terms used but not defined herein shall have the meaning attributed them in the Asset Purchase Agreement.

WHEREAS, under the terms of the Asset Purchase Agreement, Seller has conveyed, transferred and assigned to Assignee, as an affiliate and assignee of Buyer, among other assets, certain intellectual property of Seller, and has agreed to execute and deliver this IP Assignment, for recording with the United States Patent and Trademark Office, the United States Copyright Office and corresponding entities or agencies in any applicable jurisdictions.

NOW THEREFORE, The parties agree as follows:

1. **Assignment.** For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, including without limitation the consideration contemplated in the Asset Purchase Agreement, Seller hereby irrevocably conveys, transfers and assigns to Assignee, and Assignee hereby accepts, all of Seller's right, title and interest in and to the following (the "Assigned IP"):

(a) all inventions related to the Business that are currently known, in use or under development, whether or not yet reduced to practice and whether or not the subject of a patent or patent application, and all patents and patent applications filed anywhere in the world, including but not limited to the patents and patent applications set forth on Exhibit A hereto and all issuances, divisions, continuations, continuations-in-part, reissues, extensions, reexaminations and renewals thereof (the "Patents");

(b) all trade names, trademarks, service marks, logos, trade dress, and similar rights, together with all trademark registrations and applications filed anywhere in the world, including but not limited to the trademark registrations and applications set forth on Exhibit B hereto and all issuances, extensions and renewals thereof (the

"Trademarks"), together with the goodwill of the business connected with the use of, and symbolized by, the Trademarks;

(c) All original works of authorship and all copyrights (registered and unregistered) associated therewith;

(d) all rights of any kind whatsoever of Seller accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;

(e) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(f) any and all claims and causes of action, with respect to any of the foregoing, whether accruing before, on and/or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. **Recordation and Further Actions.** Seller hereby authorizes the Commissioner for Patents and the Commissioner for Trademarks in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this IP Assignment upon request by Assignee. Following the date hereof, upon Assignee's reasonable request, and at Assignee's sole cost and expense, Seller shall take such steps and actions, and provide such cooperation and assistance to Assignee and its successors, assigns and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be necessary to effect, evidence or perfect the assignment of the Assigned IP to Assignee, or any assignee or successor thereto.

3. **Terms of the Asset Purchase Agreement.** The parties hereto acknowledge and agree that this IP Assignment is entered into pursuant to the Asset Purchase Agreement, to which reference is made for a further statement of the rights and obligations of Seller and Assignee with respect to the Assigned IP. The representations, warranties, covenants, agreements and indemnities contained in the Asset Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Asset Purchase Agreement and the terms hereof, the terms of the Asset Purchase Agreement shall govern.

4. **Counterparts.** This IP Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this IP Assignment delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this IP Assignment.

5. **Successors and Assigns.** This IP Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

6. **Governing Law.** This IP Assignment and all disputes and controversies arising hereunder shall be governed by and construed in accordance with the laws of the State of Texas without reference to such state's principles of conflicts of law. The parties hereto agree to pursue any dispute, controversy or claim arising under this IP Assignment pursuant to the applicable provisions of the Asset Purchase Agreement.
