DISSEMINATION OF VIDEO FILES TO MOBILE COMPUTING DEVICES OVER A COMMUNICATIONS NETWORK

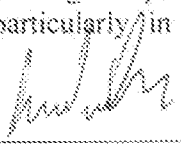
(hereinafter "invention") for which Assignor is making or has made application for LETTERS PATENT OF THE UNITED STATES. AND WHEREAS,

And Assignor does hereby request and authorize the U.S. Commissioner of Patents and Trademarks and its foreign counterparts to issue said LETTERS PATENT when granted, in accordance with this assignment.
