Assignor hereby further assigns to Assignee all claims and causes of action for infringement of the patent rights assigned herein, including the right to sue for, and collect damages for, any and all acts of past and future infringement.

Assignor hereby grants Lowe Hauptman & Ham, LLP, 2318 Mill Rd, Suite 1400, Alexandria, VA 22314, the power to insert on this assignment any further identification which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.
