This Plan of Conversion (the "<u>Plan</u>"), dated August 26, 2011, is adopted for the purpose of converting Lochinvar Corporation, a Tennessee corporation (the "<u>Corporation</u>"), to a Tennessee limited liability company (the "<u>Conversion</u>").

1. <u>Certificate of Conversion</u>. The Corporation shall cause to be filed with the Secretary of State of the State of Tennessee a Certificate of Conversion in the form attached hereto as <u>Exhibit A</u> (the "<u>Certificate of Conversion</u>"), pursuant to the requirements of Section 48-249-703 of the Tennessee Limited Revised Liability Company Act, as amended (the "<u>LLC</u> <u>Act</u>") and the requirements of Section 48-21-111 of the Tennessee Business Corporation Act, as amended (the "<u>Act</u>").

5. <u>Articles of Organization</u>. The organizer of the LLC shall cause to be filed with the Secretary of the State of the State of Tennessee, the Articles of Organization, in the form attached hereto as <u>Exhibit B</u> (the "<u>Articles of Organization</u>").
