**PATENT ASSIGNMENT
NUNC PRO TUNC**

This PATENT ASSIGNMENT (this "Patent Assignment") is executed and delivered as of December 27, 2012 by and between Photomedex, Inc., a Nevada corporation ("PHMD"), and PhotoMedex Technology, Inc., a Delaware corporation ("P-Tech").

WHEREAS, PHMD owns the entire right, title, and interest in and to each patent and application for patent listed on Exhibit A hereto, and the inventions described in and underlying such patents and patent applications (collectively, the "Patents"); and

WHEREAS, PHMD wishes to assign to P-Tech all right, title and interest in and to the Patents, and P-Tech desires to secure the entire right, title and interest in and to the Patents.

NOW, THEREFORE, be it known by all whom it may concern, that for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged,

1. PHMD agrees to and hereby does sell, convey, assign, transfer and deliver to P-Tech, its successors and assigns, and P-Tech hereby purchases, accepts and acquires, all of the entire right, title and interest in and to the Patents, including the right to sue for and collect for P-Tech's sole benefit all damages for any past infringement of the Patents. The assignment of the Patents shall include the right to file domestic patent applications under the laws of the United States and all other countries that claim the benefit of any of the foregoing patents or applications, and to file foreign patent applications in the name of P-Tech or its affiliates, wherever such right may be legally exercised, including the right to claim the benefits of the International Convention for such applications.
2. PHMD hereby authorizes and requests the United States Commissioner of Patents, and the Patent Office officials in foreign countries as are duly authorized by the respective foreign patent laws to issue patents, to issue any and all patents directed to the Patents to P-Tech as the owner thereof.
3. PHMD hereby agrees to execute all documents, assist in all proceedings and take any reasonable further steps as P-Tech may deem necessary (at the sole cost and expense of P-Tech) to effectuate the transfer of the Patents to P-Tech, or the perfection, registration, or recordation of the rights of P-Tech thereto, as P-Tech may reasonably deem appropriate. If PHMD does not, within fifteen (15) days of presentment, return the requested executed documents, then P-Tech is hereby granted a limited power of attorney to execute all such documents on behalf of PHMD in accordance with 37 C.F.R. § 3.73. This power of attorney is coupled with an interest and is irrevocable.
4. Construction and interpretation of this Patent Assignment shall be governed by the Laws of the State of New York, excluding any conflicts or choice of law, rule or principle that might otherwise refer construction or interpretation of this Patent Assignment to the substantive Legal Requirement of another jurisdiction.

5. This Patent Assignment may be executed in two counterparts, and each such counterpart hereof shall be deemed to be an original instrument, but both such counterparts together shall constitute but one agreement. Delivery of an executed counterpart of a signature page of this Patent Assignment by facsimile or other electronic transmission shall be effective as delivery of a manually executed original counterpart of this Agreement.
