ASSIGNMENT

TO BE BINDING on the heirs, legal representatives, and assigns of the undersigned and extend to the successors, assigns, and other legal representatives of the Assignee.

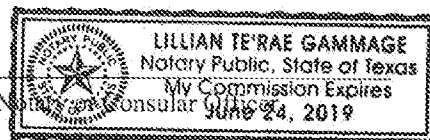
