ASSIGNMENT AND AGREEMENT



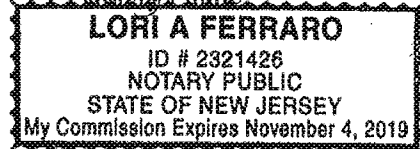


