
## ASSIGNMENT

This Assignment includes the right, if any, for Assignee to sue or bring other actions for past, present and future infringement. Furthermore, this Assignment shall be deemed a full legal and formal equivalent of any assignment, consent to file or like document which may be required in any country for any purpose regarding the subject matter hereof.
