and

(the Assignors and the Assignee being jointly referred to as "the Parties")

**WHEREAS:**

(A) The Assignor owns rights in one or more designs entitled "Open Tank Device", identified by Assignee case number D13114782, as shown in the design drawings attached hereto and hereinafter referred to as 'the Designs';

(B) The Assignee intends to file one or more design registrations utilising subject matter of the Designs, the filing details of which may be added in a Schedule to this Assignment subsequent to execution of this Assignment for convenience of reference; and

In consideration of the sum of one pound sterling (£1.00) and other good and valuable consideration paid by the Assignee to the Assignor (the receipt of which is hereby acknowledged) the Assignor hereby assigns to the Assignee, in all territories of the world, all of the Assignors' right, title and interest in the Designs, and all rights to apply for and obtain registered designs or other forms of protection in respect of the Designs in all countries of the world, including all rights to claim priority of any such registered designs and including the right to recover and take all such proceedings as may be necessary for the recovery of damages or otherwise in

respect of all infringements of any design registration or registrations granted in respect of the Designs whether such infringements take place before or after the effective date of this assignment TO HOLD the same unto the Assignee absolutely.

The Assignor undertakes to execute documents and perform other acts reasonably required to enable the Assignee to enjoy the full benefit of the property and rights hereby assigned and to apply for and effectively vest in design registrations and other rights in respect of the assigned rights throughout the world.

This Assignment shall be governed by and construed in accordance with English law and each party agrees to submit to the exclusive jurisdiction of the courts of England and Wales.


