ARTICLES OF ORGANIZATION OF
KAPAK COMPANY LLC

THE UNDERSIGNED ORGANIZER, being a natural person 18 years of age or older, in order to form a limited liability company under Minnesota Statutes, Chapter 322B, hereby adopts the following Articles of Organization:

ARTICLE 1
NAME

The name of this Company (the "Company") is: Kapak Company LLC

ARTICLE 4
TERM

Unless dissolved earlier according to law, this Company shall exist perpetually from the date these Articles of Organization are filed with the Minnesota Secretary of State.

ARTICLE 5
MEMBERSHIP INTERESTS

If the Company at any time shall have governors, then in addition to any and all powers conferred upon the Company's board of governors (the "Board") by the laws of the State of

Minnesota, the Board shall have the authority to define membership interests, to establish by resolution more than one class or series of membership interests, and to fix the relative rights, restrictions and preferences of any such classes or series of interests, and the authority to issue membership interests of a class or series to another class or series in any manner that the Board deems necessary, subject to any contrary provisions set forth in a member control agreement signed by all of the members of the Company (and all persons who have signed contribution agreements with respect to the Company), as amended from time to time.

No member of this Company shall have any preemptive rights as provided in Minnesota Statutes, Section 322B.33.

The Board, if any, shall have the authority to adopt a procedure restating the value of previous capital contributions by the members, but shall not do so unless profits, losses and distributions are to be shared in proportion to the value of the capital contributions of the members as of the date of any such restatement, or in any other proportion determined pursuant to a member control agreement signed by all of the members of the Company (and all persons who have signed contribution agreements with respect to the Company), as amended from time to time.

The members shall share profits, losses and distributions in the proportion specified in a member control agreement signed by all of the members of the Company (and all persons who have signed contribution agreements with respect to the Company), as amended from time to time. Members may be admitted to or expelled from the Company as provided in such a member control agreement. In the absence of a member control agreement, the members shall share profits, losses and distributions as contemplated by Minnesota Statutes, Chapter 322B.

ARTICLE 6 VOTING BY MEMBERS

No member of this Company shall have any cumulative voting rights. Members shall have the right to vote as described in the member control agreement signed by all of the members of the Company, as amended from time to time or, if there is no member control agreement, shall have the right to vote as contemplated by Minnesota Statutes, Chapter 322B. To the extent specified in these Articles or such a member control agreement, the proportion of votes needed for an action of the members may exceed a majority of the voting power of the membership interests present and entitled to vote at a duly held meeting, except as otherwise provided by applicable law.

ARTICLE 7 MEMBER ACTION WITHOUT MEETING

Any action required or permitted to be taken at a meeting of the members may be taken by written action signed by the members who own voting power equal to the voting power that would be required to take the same action at a meeting of the members at which all members are present.

ARTICLE 8
RESTRICTION ON TRANSFER OF GOVERNANCE RIGHTS

A member's governance rights may be transferred to a person not already a member only: (a) with the consent of all of the members (and all persons who have signed contribution agreements with respect to the Company); or (b) as otherwise described in a member control agreement, as amended from time to time.


ARTICLE 9
GOVERNORS / INITIAL MEMBERS

The names of the Company's initial governors shall be set forth in a written action of the Organizer unless the Company determines to have no Board. In such a case, the Organizer shall accept contributions from the Company's initial members. If the Company has a Board, any action required or permitted to be taken at a meeting of the Board and not needing approval by the members may be taken by written action signed by the number of governors that would be required to take the same action at a meeting of the Board at which all governors are present.

ARTICLE 10
LIMITATION ON GOVERNORS' LIABILITY

If the Company has a Board, no governor of this Company shall be personally liable to the Company or its members for monetary damages for breach of fiduciary duty by such governor as a governor; *provided, however*, that this Article 10 shall not eliminate or limit the liability of a governor to the extent provided by applicable law: (a) for any breach of the governor's duty of loyalty to the Company or its members; (b) for acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law; (c) under Section 322B.56 or 80A.23 of the Minnesota Statutes; or (d) for any transaction from which the governor derived an improper personal benefit. No amendment to or repeal of this Article shall apply to or have any effect on the liability or alleged liability of any governor of the Company for or with respect to any acts or omissions of such governor occurring prior to such amendment or repeal.
